## Abstract

This document was prepared by Daniel B. Beckett, Jr. (of Plymouth MI) with assistance from Mark Berman (of Malta). Mr. Beckett and Mr. Berman have summarized and collated this report from information collected from and submitted by victims of Mark Johnston *et al.* Beckett and Berman compiled the information through a variety of communication mediums, including face-to-face meetings, telephone conversations, email exchanges, and so-called "private messages" on a variety of internet-based discussion forums. The intent of this document is to present compelling evidence that Mr. Johnston systematically engaged in a pattern of felonious behavior whereby he perpetrated acts of larceny and fraud against more than 30 individuals or businesses in at least 16 states and 8 foreign countries.

## Summary of Allegations

- Committed larceny and/or fraud against members of several Porsche- and carrelated internet-based discussion forums
- Committed larceny and/or fraud against automotive suppliers local to Southeast Michigan (Diamond Racing, Holbrook Racing)
- Specifically targeted overseas victims (Australia, Norway, Estonia, Malta, Canada, UK, and two servicemen in Iraq) although he victimized members in at least 16 states as well (AL, CT, CO, FL, IN, IL, MI, MN, MO, NE, NH, NY, SC, TX, VA, WA)
- Perpetrated acts of "Uttering and Publishing", a felony offense, which includes writing bad checks and credit card fraud
- Perpetrated acts of "Wire Fraud", a federal offense, which includes fraudulent transactions over state and federal lines
- Perpetrated acts of larceny which includes the improper seizure of goods
- Masqueraded under a number of aliases in all of the aforementioned forums, eBay and PayPal as detailed below (note that Mr. Johnston may have used and may still be using a variety of other aliases which may remain undiscovered
- Used the aforementioned forums, eBay and PayPal to establish trust by delivering goods and services in small amounts. Then he would approach the individual "out-of-band" of those environments (e.g. using in-person meetings, email or phone numbers exchanged during previous transactions) and set them up for larger fraud. Typical examples included barter deals to provide services in exchange for access to body panels, racing components, or engine parts which he claimed he wanted to duplicate and resell under the fraudulent business monikers including "Fossil Fuel", "Hausbrauen Motoren", "HBM", and "Nemesis Motorsports".
- Individual instances of fraud are relatively small, most in the range of <\$500, but there are some cases in the range of \$1000-\$2000
- Exact amount of larceny and/or fraud is unknown; best estimates indicate that it is at least \$18,152.72, but probably surpasses \$20,000 during a four year span from July 2003 through October 2007.
